*The Russian aggression in Ukraine called for an unprecedented response in Europe. Meanwhile, the political, economic and social challenges posed by the pandemic have shown the need for negotiated and internationally shared solutions. Looking beyond the emergency posed by the pandemic, systemic challenges such as the fight against climate change and efforts for sustainable development, peace and Euro-Atlantic security require common interventions by key international actors, a stronger role for the multilateral system and a more systematic involvement of local actors.*

*The Istituto Affari Internazionali – within the framework of the strategic partnership with Fondazione Compagnia di San Paolo - is organising the international conference “Global thinking, local action. A look from Turin on global governance after the war on Ukraine” which will take place on 5-6 July 2022 in Turin at Palazzo Madama. The meeting will focus on the dimensions of international governance that are most significant for Italian foreign policy. The initiative aims to put into perspective the role of multilateralism in the light of the new international context shaped by the pandemic, its medium and long-term effects on global governance structures and the consequences of the war in Ukraine. The European and global level will be considered, as well as some of the most important policy areas that concern Italian foreign policy and the contributions of actors at the local level, including within civil society.*

- 15.45-16.45 **SESSION II – *The Transatlantic Relations in the light of the New NATO Strategic Concept***  
*The NATO Strategic Concept prepared for the Madrid Summit in June 2022 will reflect both fundamentals of the Atlantic Alliance and changes of recent years. The collective defence of member states will be the top priority in view of the Russian aggression in Ukraine, while crisis management in the Euro-Atlantic area will remain on the agenda, as well as partnerships with third states, particularly those that are democratic and/or closer to the West in the context of strong geopolitical competition with Moscow and Beijing. The panel will reflect on how, more than ever before, Europe and North America need to cooperate on the aforementioned fields, with particular attention to the new cyber and space operational domains, to a functional industrial and technological policy to guarantee Euro-Atlantic security, and to a relaunch of non-proliferation and arms control negotiations at the global level.*

*Since 2003, the Middle East and North Africa have witnessed wars, revolutions and upheavals, while the EU increasingly turned inward-looking. However, the broad Mediterranean space has become the subject of intense geopolitical dynamics, while important socio-economic issues remain unresolved. As the EU is now busy channelling its energies eastwards, this panel draws attention to how the Russian invasion of Ukraine is having a profound impact on an already fragmented and fragile Mediterranean space, with the aim of providing concrete policy recommendations for the EU to regain a relevant role in promoting (human) security in the Mediterranean area.*

#### **SESSION IV – The European reform agenda and the PNRR**

*The war in Ukraine is complicating a global economic picture already made difficult by the pandemic and its dramatic consequences. Many European governments are struggling to cope with the consequences of the conflict and to devise a recovery plan for an economy which has already suffered from a long period of stagnation. The allocation of the Recovery and Resilience Facility (RRF) was designed by the European Commission precisely to help those economies of the member states that are in most distress. The RRF is the largest grant of the 'Next Generation EU' recovery plan. The aim of the round table is to analyse the opportunities offered by the PNRR to the economies of cities, looking at the most involved sectors and the priorities of local actors and economic operators.*

#### **SESSION V – Reconciling energy security and decarbonisation in Europe**

*The international political environment and the fluctuating fuel prices are producing alarming cascading effects on a world economy already affected by COVID-19 and climate change. This multidimensional crisis undermines the path towards the UN's 2030 Agenda (SDGs). In Europe, the state of preparedness for the energy crisis has been insufficient, despite the progressive integration of energy and climate policies and various past attempts to diversify the energy supply. These important vulnerabilities occur while significant energy and climate policy decisions are being negotiated in Brussels in the context of the European Green Deal and the 'Fit for 55' package. The panel will discuss the triangulation between the challenges of energy security, decarbonisation and competitiveness and the role of the EU (and Italy) in this context.*

**SESSION VI – Global crisis, the restructuring of value chains and relaunch of economic cooperation in the Mediterranean**

*The Covid-19 pandemic and the conflict in Ukraine have shown the fragilities of global value chains and risk accelerating the process of decoupling the global trading system. The level of global economic interconnectedness and strategic dependence in the supply of raw materials and key products makes it a priority to choose industrial policies that ensure the resilience of the EU Single Market. The implications of this process of restructuring the position of Italy and the EU within the international production networks may favour the revitalisation of trade and transport routes in the Mediterranean and the related port and logistics infrastructure. The panel will reflect on the geopolitical, economic and infrastructural prospects for Italy and Europe in the processes of nearshoring, shortening of supply chains and logistics, and possible regionalisation in the Mediterranean.*
