11:45-13:15 **Session II – New Forms of Conflict and Arms Control in the Middle East**

This session will look into the security challenges and conflict dynamics in the Middle East region with particular regard to three major issues: the latest developments in the ongoing conflicts and their regional reverberations; the future of the Joint Comprehensive Plan of Action (JCPOA) and the prospect for regional arms control, including the EU-sponsored proposal for a Weapons-of-Mass-Destruction (WMD) Free Zone in the Middle East; the changing political alignments and the role played by external powers. The panel and the subsequent debate will aim to explore the concrete possibilities of new forms of international cooperation involving Iran that can contribute to lessening the tensions between rival actors and paving the way for a concerted management of conflict situations.
