New Visions for the Western Balkans: EU Accession and Regional Security

AGENDA

The EU-Western Balkans integration process is at a crossroads. The Russian invasion of Ukraine makes it imperative for the EU and the Western Balkans to reaffirm their strategic choice for a common European future and to work together to accelerate the enlargement process. The region's progresses towards fundamental reforms and in the processes of intra-regional and European integration today seem the only options to ensure peace, security and prosperity in this part of Europe. However, some problems in the Western Balkans are still outstanding and continue to weigh on the membership prospects of these countries. These obstacles are in particular linked to the still unresolved bilateral disputes, partial compliance with the Copenhagen accession criteria and still limited convergence towards EU's socio-economic and environmental standards.

Against this backdrop, the Western Balkans represent both a challenge and an opportunity for the Italian government. Over the years, Italy has consistently pursued a European agenda for the Western Balkan countries, which has been in line with its strategic national interest for political, economic, and security reasons. Nonetheless, Italy has not always fully exercised its political weight in the European context. While German Chancellor Olaf Scholz has clearly committed to the continuation of the enlargement process and the "Berlin Process", the French President Emmanuel Macron launched the European Political Community. In such a dynamic context, Italy has the potential to play an active role and strive for synthesis among various visions over the future of Europe and the Western Balkans.

All this considered, the Istituto Affari Internazionali (IAI) and the Osservatorio Balcani Caucaso Transeuropa (OBCT), with the support of the Italian Ministry of Foreign Affairs and International Cooperation and in the framework of the strategic partnership with Compagnia di San Paolo Foundation, will host a two-day meeting in Rome to discuss expectations and prospects for the medium-term future of the Balkan region. The meeting will include high-level representatives and policy makers and civil society representatives, both from the region and the EU. The aim is to promote an informal gathering to discuss mutual expectations and develop further concrete initiatives for cooperation between the countries of the region and with EU member countries.

15.30-17.00 PANEL I: PROMOTING EU-WESTERN BALKANS' INTEGRATION, WHAT FUTURE FOR THE REGION?

The relations between the EU and the Western Balkans, as well as the prospects for EU accession of the countries in the region, depends on their respective visions of the future. Recently, a number of proposals have emerged in this regard, suggesting different ideas for the future of Europe. Some of such proposals envisage ad hoc measures to accelerate the EU accession of the Western Balkans and "phasing in" their integration process into specific sectors, in line with what foreseen by the European Commission's new enlargement methodology. Others, put forth new formats for these countries' staged EU accession and gradual membership. At the same time, the EU strategic debate has recently witnessed the French President's proposal for the establishment of a European Political Community. In this context, the panel will promote a discussion between relevant actors on the visions of Europe and the Western Balkans.

17.30-19.00 PANEL II: SUPPORTING REGIONAL COOPERATION AND INTEGRATION AMONG THE WESTERN BALKAN COUNTRIES

Initiatives to accelerate regional cooperation and integration among Western Balkans are essential to promote the reconciliation, stability, and growth of these countries. Most importantly, regional integration plans offer them the opportunity to engender local ownership and responsibility. In recent years, Western Balkan leaders agreed on two important projects for regional economic integration: the Multi-annual Action Plan on Regional Economic Area 2017–2019 (REA); and Common Regional Market 2020–2024 (CRM). Such projects have received substantial support from the European Commission, especially through the recent Economic and Investment Plan (EIP). In parallel, new developments have emerged under the so-called "Open Balkans" (OB) initiative which similarly promotes economic and political cooperation in the Western Balkans, but include only Albania, North Macedonia and Serbia. Considering all of this, the panel will promote a discussion among regional actors on whether, and if so how, these plans may foster positive and sustainable transformations.
